Dear Dr. Laura:

Apparently on her radio show, Dr Laura Schlesinger said that, as an observant Orthodox Jew, homosexuality is an abomination according to Leviticus 18:22, and cannot be condoned under any circumstance. Supposedly the following response was a letter to Dr. Laura, penned by a Professor at the University of Virginia.

Dear Dr. Laura:

Thank you for doing so much to educate people regarding God's Law. I have learned a great deal from your show, and try to share that knowledge with as many people as I can. When someone tries to defend the homosexual lifestyle, for example, I simply remind them that Leviticus 18:22 clearly states it to be an abomination... End of debate.

I do need some advice from you, however, regarding some other elements of God's Laws and how to follow them.

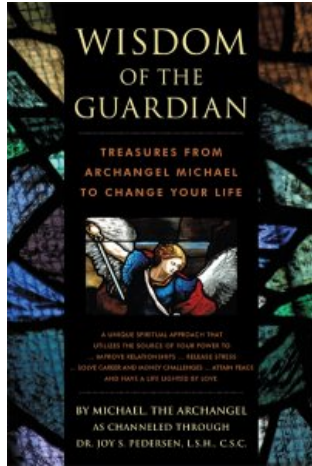

3. I know that I am allowed no contact with a woman while she is in her period of menstrual uncleanness - Lev.15: 19-24. The problem is how do I tell? I have tried asking, but most women take offense.
4. When I burn a bull on the altar as a sacrifice, I know it creates a pleasing odor for the Lord - Lev.1:9. The problem is, my neighbors. They claim the odor is not pleasing to them. Should I smite them?
5. I have a neighbor who insists on working on the Sabbath. Exodus 35:2. clearly states he should be put to death. Am I morally obligated to kill him myself, or should I ask the police to do it?
6. A friend of mine feels that even though eating shellfish is an abomination - Lev. 11:10, it is a lesser abomination than homosexuality. I don't agree. Can you settle this? Are there 'degrees' of abomination?
7. Lev. 21:20 states that I may not approach the altar of God if I have a defect in my sight. I have to admit that I wear reading glasses. Does my vision have to be 20/20, or is there some wiggle- room here?

8. Most of my male friends get their hair trimmed, including the hair around their temples, even though this is expressly forbidden by Lev. 19:27. How should they die?

9. I know from Lev. 11:6-8 that touching the skin of a dead pig makes me unclean, but may I still play football if I wear gloves?

10. My uncle has a farm. He violates Lev.19:19 by planting two different crops in the same field, as does his wife by wearing garments made of two different kinds of thread (cotton/polyester blend). He also tends to curse and blaspheme a lot. Is it really necessary that we go to all the trouble of getting the whole town together to stone them? Lev.24:10-16. Couldn't we just burn them to death at a private family affair, like we do with people who sleep with their in-laws? (Lev. 20:14)

I know you have studied these things extensively and thus enjoy considerable expertise in such matters, so I am confident you can help. Thank you again for reminding us that God's word is eternal and unchanging.

Archangel Faith's Perspective/Question:

There are many misconceptions about both religion as well as history. What I say now, I say with great reverence to all, as well as to their beliefs.

You must realize that all of life is seen from a particular perspective. Each one's perspective reveals the history of their experience and their vision of the future. Until you are exposed to another's point of view, all you have is your own. When revealed, it brings attention to the view point of another. It is more the view point that matters in this case than the actual historical occurrence. Because you cannot separate perspective from a situation, it is the perspective that matters more than what actually happened. What happened is in the eye of the beholder.

You view life through your filters. Your filters show you and point out certain aspects of the scene you see from the perspective of your mind, your memory and your history. You see things as you choose to see them.

If, however, you are open to seeing life through the eyes of another, you can then put on their glasses and view their world and perspective by listening to and hearing them out with an open, non-judgmental mind.

Is there absolute truth? Maybe. Maybe not. Does it matter? Maybe. Maybe not. Why do you care? That is the real question. Why does it matter what is real or not, true or not, or if it happened or not? What is the real reason you feel compelled to know that information? Ask yourself that question for a change. See what you determine there.
